Payroll Giving is an easy and tax-efficient way to make a regular donation to Autism NI from your salary.



How does your donation help?

- £10** will provide a family with a tailored information pack.
- £20** will provide a 30 minute Helpline call for an autistic adult or family member.
- £30** will provide an hour advice session for autistic people and their families.

Why sign up to Payroll Giving?

Autism NI supports autistic people and their families, and campaign for autism acceptance within society. Our vision is to build an inclusive society where autistic people can reach their full potential.

Almost 90% of our income is spent on providing a range of local services to autistic people and their families across Northern Ireland. By signing up to Payroll Giving and pledging a regular donation, your ongoing help means we can continue to support our vibrant autism community.

How it works

If your salary is paid through your company, you can donate through your company's Payroll Giving Scheme.

Setting up to donate through Payroll Giving means that your donation will cost you even less than it would usually, as it comes out of your salary before tax is deducted. This means that if you are a basic rate tax payer and if you choose to give £10 a month to Autism NI, the gift will only cost you £8 from your net pay. If you pay a higher rate of tax, £10 a month will only cost you £6 from your net pay. In every case, Autism NI will receive the full amount of the donation you have pledged.

How do I sign up?
