
# **Chairperson Foreward**

## **About Autism NI**

Autism NI is Northern Ireland's longest serving autism charity and we have provided life changing services for autistic people and their families for over 30 years. We inspire, educate, and empower local communities, businesses, and our government to support an inclusive society where everyone understands and accepts autistic people.

We recognise that a lot has changed in 30 years and awareness of autism has increased, but we also know that there is a long way to go in relation to the general public's understanding of how to support an autistic person through a person-centred approach. We will therefore continue to work in a shared partnership approach with autistic people and their families and deliver essential services across Northern Ireland. By working together, we can achieve so much more and create a better, fairer, and more understanding society for autistic people.

## **Our services**

Autism NI offers local support services for autistic people and their families across the country. Our Helpline provides advice, information and resources for autistic people, parents and carers, as well as professionals. Our Early Intervention Service provides one-to-one support for families after their child has received an autism diagnosis. We also facilitate a Support Group Network that provides support for parents and carers throughout local communities. The Charity also provides specialised support for young autistic people through a Mental Health and Autism Project and a Girls and Autism Project and autistic people who identify as LGBTQIA+.

The Charity is the longest serving autism training provider in Northern Ireland and delivers a range of accredited training to parents, carers, and professionals. We also have an Autistic Adult Support Service as well as an Autistic Peer Network, which provides supports for our autistic adults in a way that works to their needs.

On a wider level, Autism NI provides the secretariat for the All Party Group on Autism within the Northern Ireland Assembly. Through this work the Charity has successfully lobbied for two pieces of autism legislation within the past ten years, the Autism Act of 2011 and the Autism (Amendment) Act 2022.



- **Influence change** within society through raising understanding and acceptance and make services accessible for autistic people.



# PriorityONE Listen



## **Aim**

We want to ensure that we are doing what autistic people need, through engaging and consulting with them on everything we do.

For too long autistic people have been marginalised with little, to no say in what services they feel would best support them. We want to change this narrative and therefore we believe that our autism community must be involved in the decisions we make in how we design and deliver our services.

### What we will do:

- We will work with our Autistic Peer Networks to help us develop new training and support courses
- We will consult with autistic people and their families on what services they feel would benefit them
- We will use data from our services to directly influence what areas of work and emerging issues that we need to prioritise
- We will continue to advocate and lobby on issues that are pertinent for autistic people.
- We will work in partnership with other organisations to ensure autism has as big a voice as possible.
- We will listen to autism research professionals whose expertise identifies emerging areas of need.



# Priority TWO Support



## **Aim**

Provide the right support for autistic people and their families to ensure they lead fulfilled lives.

We exist to support the 35,000 autistic people living in Northern Ireland and their families. This will always be our main priority and it will never change. Our team will continue to work in partnership with our autistic community to shape our services and bring forth evidence-based projects.

### What we will do:

- Increase accessibility of information, advice and support available to parents, carers, family members, autistic adults and professionals through our Helpline
- Increase the number of people availing of autism services in Northern Ireland through better promotion and awareness of what we do.
- Provide a 'first port of call' to parents and carers of a newly diagnosed child through our Early Intervention Service.
- Provide support to newly diagnosed autistic adults through an Adults Support Service.
- Support autistic adults in the community who have recently received a diagnosis through the Autistic Peer Networks.
- Provide support for autistic girls in the community, at home and at school through a Girls and Autism Project
- Provide support for autistic people and their mental health through a range of personal support.
- Expand and promote our Parent Support Network in local communities through engaging with parents and carers of newly diagnosed autistic children
- Improve the reach and accessibility of the Charity's services through digital technology to ensure autistic people and their families are aware of the supports available to them.

# PriorityTHREE Empower



## **Aim**

Empower and educate to improve understanding and support for autistic people.

We want to build an inclusive society for autistic people in Northern Ireland and we can't do this on our own. We need to collaborate with local business, employers, schools and education establishments, healthcare professionals, local government bodies and other charities to educate and influence changes that work best for our autism community.

### What we will do:

- Ensure training courses are co-designed with autistic people
- Increase the number of professionals receiving autism training to best support autistic people in the workplace and promote accessibility and best practice
- Expand the range and style of training courses offered to ensure accessibility
- Increase campaigns through digital technology
- Increase public understanding and participation during World Autism Acceptance Week and increase the promotion of campaign message
- Provide clear information and advice to autistic people and their families when they are seeking support
- Inform local government bodies of what autistic people need through evidence-based research
- Influence policy to ensure autistic people are getting the right support and services in Northern Ireland.



# PriorityFOUR Influence change

## **Aim**

Campaign and influence positive change within society through building understanding, acceptance and accessibility to services for autistic people.

We want to change public attitudes and understanding of autism to ensure autistic people can live in an inclusive society where they will not face any barriers and live a fulfilled life. We are committed to improving public knowledge on autism, sharing practical strategies and overcoming stereotypes.

### What we will do:

- Work in collaboration with autistic people to ensure their voices for change are heard and met
- Increase promotion of acceptance campaigns through digital technologies
- Provide a platform to amplify autistic voices that will inspire others to make a difference in their society
- Grow our support networks in local communities and work with them to promote positive change in their area
- Develop the range of training and support courses available for parents, carers, professionals and autistic adults
- Campaign and lobby for positive change at government level to ensure all autistic people have the right services at the right time
- Build relationships with decision-makers and work with other organisations to support joint lobbying campaigns.
